
Recruitment of one position of Senior Research Fellow on contractual basis for the Project Nilgiri Tahr, Coimbatore office which is the nodal office for implementing the activities of the Project Nilgiri Tahr. **This position is purely on a temporary basis (Eligible for Indian Nationals only).** Interested candidates may apply online. Details of the vacancy and application procedures are given below.

Tamil Nadu Forest Department, Government of Tamil Nadu, invites applications from Indian Nationals for a contractual position of Senior Research Fellow for carrying out the project related activities under Project on Nilgiri Tahr. The candidate with experience on working on mountain ecosystem, or larger ungulates would be given preference. The candidate should be physically fit to trek in the higher elevation mountain and willing to stay in forest with minimum basic facilities. 1. Age limit for Senior Research Fellow is 30 years as on **05.02.2026** However, the upper age limit may be relaxed up to 5 years in the case of candidates belonging to SC/ST/OBC and Women applicants as per Government of Tamil Nadu norms.

Application should be in the prescribed format, duly signed and should be accompanied by self-attested copies of documents on educations qualification, research experience, extracurricular activities, date of birth, mark sheets of all examinations, community certificate (if seeking relaxation as per Government of Tamil Nadu rules) etc.
3. The Forest Department will not provide accommodation and no TA/DA will be paid to the candidates appearing for the personal interview. The interview will be in either online or physical mode.
4. At the time of the verification of original documents or even after selection, if it is found that an attempt has been made by the applicant to willfully conceal, misrepresent the facts or canvass, such application will be rejected, and due action will be taken against the candidate.
