Application should be in the prescribed format, duly signed and should be accompanied by self-attested copies of documents on educational qualifications, research experience, UGC/CSIR/GATE certificate (if any), extracurricular activities, date of birth, mark sheets of all examinations, community certificate (if sought relaxation as per Government of Tamil Nadu rules), etc.
